5. Use Correct Ammunition
6. If Your Gun Fails To Fire When The Trigger Is Pulled, Handle With Care!
7. Always Wear Eye And Ear Protection When Shooting
8. Be Sure The Barrel Is Clear Of Obstructions Before Shooting
9. Don't Alter Or Modify Your Gun, And Have Guns Serviced Regularly
10. Learn The Mechanical And Handling Characteristics Of The Firearm You Are Using

I, the undersigned, Releasor, being of lawful age, inconsideration of being permitted to be the participant and/or guest in the matches at Tusco Rifle Club Inc., or at any other place where such matches may be conducted, do for myself, my spouse, legal representatives, heirs and assigns, hereby release, waive and forever discharge Tusco Rifle Club Inc., its agencies, departments, its officers, trustees, agents, service and or club members, and employees in their official and personal capacities, their heirs, administrators and executors from any and all liability for any and all loss or damage and from any and every claim, demand, action and right of action of whatever kind of nature, either in law or equity, arising from or by reason of death, or any bodily injury or personal injuries known or unknown, or property damage resulting from any incident which may occur during my participation at said matches or any activities in connection with these matches, whether caused in whole or in part by the Releases or otherwise.

I hereby assume full responsibility for the risk of bodily injury, death, property damage, and any theft, unexplained disappearance or damage which may befall any of my property or property accompanying me during the period of the match or while on the premises where any of the matches and social activity occurred while competing, officiating, working, spectating or for any purpose participating in the match or just being on the premises for any reason whatsoever.

I agree that this release constitutes the entire agreement between myself and Tusco Rifle Club Inc. and the terms of this release are contractual and not a mere recital and the same shall continue in force and be applicable to all matches I attend which are conducted by the Tusco Rifle Club Inc. until such time it is revoked by me in writing. Said revocation shall be effective only if made in writing, served upon Releasees by certified mail. Such revocation shall become effective ten (10) days following receipt by Releasees of said intention of revoke.

I agree that this release agreement is intended to be as broad and inclusive as permitted by law and if any portion thereof is valid, the balance hereof will, notwithstanding, continue in full legal force and effect.
